#### 2023 WAIVED FEES PROMO MECHANICS

- 1. Apply for a BDO SME Loan and enjoy waived fees up to P 30,000.
- 2. The promo is open to those SME Loan applications approved from February 14 to August 15, 2023 (Promo Period). Application may be submitted through any BDO Branch nationwide, or Online via https://www.bdo.com.ph/sme-loan-pror Approved SME Loan should be booked or availed no later than August 31, 2023 (Availment Period)
- - For SME Ready Check: Applications received within the promo period but availment not made upon credit line release date are not qualified

## The promo is offered to

- All NEW accounts availing of a Term Loan or SME Ready Check (Credit Line) facility with a minimum P 1M loan/line amount who will meet the following criteria
  - Term Loan application within the promo period should be subsequently released/availed not later than the August 31, 2023 (Availment Period).
    - · For Construction Loan, first release should be at least P 1M and within the availment period.
  - For SME Ready Check (SMERC), the initial amount drawn from the line should at least be P 1M. This amount should be availed upon release of the facility.
- EXISTING accounts who meet the following criteria:

For Term Loan Accounts:

- Additional Loan of at least P 1M with loan released on the prescribed Loan Availment Period
